- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Food Bank Emergency
- 5 Support Act of 2025".

- 2 (a) Amount Appropriated.—There is hereby ap-

- 4 wise appropriated, \$462,500,000 for expenditure under

- 8 (b) Availability of Appropriated Funds.—Dur-
