1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Expanding Access to
3 Distance Learning and Telemedicine Act”.

4 **SEC. 2. TELEMEDICINE, DISTANCE LEARNING, AND CYBER-**
5 **SECURITY SUPPORT SERVICES IN RURAL**
6 **AREAS.**

7 (a) IN GENERAL.—Section 2333 of the Food, Agri-
8 culture, Conservation, and Trade Act of 1990 (7 U.S.C.
9 950aaa–2) is amended—

10 (1) in the section heading, by striking “**TELE-**
11 **MEDICINE AND DISTANCE LEARNING**” and in-
12 sserting “**TELEMEDICINE, DISTANCE LEARNING,**
13 **AND CYBERSECURITY SUPPORT**”;

14 (2) in subsection (a)—

15 (A) by inserting “, cybersecurity support,”
16 before “and distance”; and

17 (B) by inserting “including digital literacy,
18 workforce development, and job training” be-
19 fore “in rural”;

20 (3) in subsection (c)—

21 (A) in paragraph (1)—

22 (i) in subparagraph (A)—

23 (I) by inserting “, cybersecurity
24 support,” before “or distance”; and

25 (II) by inserting “, including dig-
26 ital literacy, workforce development,

1 and job training” before the semi-
2 colon; and

3 (ii) in subparagraph (B), by striking
4 “to provide telemedicine service or distance
5 learning service” and inserting “services
6 described in subparagraph (A)”; and

7 (B) in paragraph (4), by striking “or dis-
8 tance learning” and inserting “, cybersecurity
9 support, or distance learning, digital literacy, or
10 workforce development and job training”;

11 (4) in subsection (d)—

12 (A) in paragraph (12), by striking “and”
13 at the end;

14 (B) in paragraph (13), by striking the pe-
15 riod at the end and inserting “; and”; and

16 (C) by adding at the end the following:

17 “(14) the need for distance workforce develop-
18 ment and job training, including a workforce that
19 supports the building of broadband in rural areas.”;
20 and

21 (5) in subsection (f)—

22 (A) in paragraph (2), by striking “or dis-
23 tance learning” and inserting “distance learn-
24 ing, digital literacy, or cybersecurity”;

25 (B) in paragraph (3)—

1 (i) by inserting “, cybersecurity sup-
2 port,” after “assistance”; and

3 (ii) by striking “or” at the end;

4 (C) in paragraph (4), by striking the pe-
5 riod and inserting “; or”; and

6 (D) by adding at the end the following:

7 “(5) providing distance workforce development
8 and job training, including a workforce that sup-
9 ports the building of broadband in rural areas.”.

10 (b) EFFECTIVE DATE.—The amendments made by
11 subsection (a) shall take effect on the date that is 6 month
12 after the date of the enactment of this Act.
